

## **DROPSHIPPING SERVICE - TERMS AND CONDITIONS**

### **1. Service cost**

The Brandsdistribution Dropshipment service provides 3 tariff plans for every need:

- **Monthly** at 99€ + VAT (invoicing every month)
- **Half-yearly** at 399€ + VAT (66€ per month for a savings of 195€ - invoicing every 6 months)
- **Yearly** at € 699 + VAT (58€ per month for a savings of 489€ - invoicing every 12 months)

The price of the products is the same you will find on Brandsdistribution's catalogue.

Brandsdistribution.com does not keep any percentage on the products sold.

There are no minimum quantities, neither a minimum amount to reach with the dropshipment service.

Our Dropshipping catalog can be published on one website only, excluding marketplaces.

### **2. Service activation**

The service will be activated within 24 hours after receipt of payment.

Depending on the chosen plan, the service will last for 1, 6 or 12 months.

The renewal of the subscription is automatic.

The shipping cost is always at customer charge.

#### 4. Payment terms and conditions

The final customer will pay the reseller, who sends the order and the payment to Brandsdistribution.com to confirm its shipping. The payment must be done within maximum 10 days from the order creation, otherwise your order will disappear.

The payment can be done via credit card, Paypal or Bank Transfer.

The system issues an invoice for every order.

The reseller must apply the suggested selling price visible on our website.

The suggested selling price is not blinding for the reseller, who is free to apply a higher price if he/she wishes to.

#### 5. After sales policies and goods return

It is possible to return the products up to 20 days from their reception. Customers can forward a return request from their user profile on [www.brandsdistribution.com](http://www.brandsdistribution.com) and wait for its confirmation.

If you receive damaged or wrong products, send a photo to [info@brandsdistribution.com](mailto:info@brandsdistribution.com) and a credit note will be issued.

Only in case of damaged goods, Brandsdistribution.com will be charged for the shipping fees. If the product is not damaged the shipping cost is at the charge of the reseller.
